**Re: Invitation to the EFDA Associates to participate in a Task Force E1/E2 Review Meeting, to prepare the JET Experimental Campaigns with the ITER-like Wall**

Following the 1<sup>st</sup> General planning meeting on 1-5 March 2010, preparations for the JET experimental campaigns with the ITER-like wall (ILW), enhanced neutral beam heating power and improved diagnostics are progressing rapidly with Association Staff in Working Groups formulating experimental proposals and reporting at regular Task Force Meetings, as announced in letter 7238-FR/MLW-L, dated 7 April 2010.

In order to conduct a strategic review of the preparation of the proposals for the experimental campaigns with the ILW, a Task Force E1/E2 Review Meeting will take place at EFDA-JET, Culham Science Centre, UK, starting at 10am on 8 July 2010 and finishing at 1pm on 9 July 2010.

The aim of the meeting is to provide a firm basis for the overall scope, focus and run-time requirements and priorities for exploitation of the ILW up to the end of 2013. The meeting will include summaries of the scientific topics, proposals, resources and priorities identified so far by the Working Groups and discussions to highlight omissions as well as issues for further study.

Although remote participation is possible, on-site participation is recommended for this meeting. A second Task Force E1/E2 Review meeting is scheduled for 8-9 September 2010, aiming at the completion of focussed proposals by October 2010.
