Re: Invitation to 2nd Task Force E1/E2 Review Meeting, 9-10 September 2010 at EFDA-JET

Following the 1st General planning meeting on 1-5 March 2010 and the 1st Task Force E1/E2 Review Meeting on 8-9 July 2010, preparations for the JET experimental campaigns with the ITER-like wall (ILW), enhanced neutral beam heating power and improved diagnostics have advanced rapidly.

A 2nd strategic review will take place at EFDA-JET, Culham Science Centre, UK, starting at 11am on 9 September 2010 and finishing at 2pm on 10 September 2010. Although remote participation is possible, on-site participation is strongly recommended.

While the 1st review meeting concentrated on the strategic review of proposals that emanated from each of the Working Groups, the 2nd meeting will start to determine the overall scope, priority and sequence of experiments, and where effort should be concentrated in order to converge on a balanced and focussed programme for the exploitation of the ILW up to the end of 2013, with particular emphasis on the Campaigns C28-C29 of 2011.

Looking beyond this meeting, it is essential that the preparation of experimental proposals is completed by 15 October 2010, in order to allow proper assessments by the Task Force Leaders and EFDA-JET CSU, in time for the 2nd General Planning Meeting scheduled for 15-19 November 2010. At this time proposals will be reviewed and discussed, and priorities for science and sequence will be established.


