## UNDER THE GENERAL COOPERATION AGREEMENT FOR SCIENTIFIC RESEARCH BETWEEN THE INSTITUTUL DE FIZICĂ ATOMICĂ (IFA), ROMANIA AND THE COMMISSARIAT À L'ENERGIE ATOMIQUE ET ENERGIES ALTERNATIVES (CEA) FRANCE

# CALL FOR PROPOSALS – OCTOBER 1, 2012

On the basis of the General Cooperation Agreement for Scientific Research between IFA and CEA<sup>1</sup>, according to the article 4 of the above-mentioned Agreement, the cooperation takes place also in the form of joint research and development (R&D) projects and joint support actions projects.

IFA-Romania and CEA-France are inviting CEA units and Romanian Research Institutions<sup>2</sup> to submit joint project proposals<sup>3</sup>. The purpose of the funding is to stimulate new collaborations, which should result in joint R&D projects and joint applications to European (including future IFA-CEA) programmes and initiatives. The estimated annual budget of this call for the next three years is 500 000 Euro granted by each side.

## 1. Joint Research and Development Projects / Deadline: November 16, 2012

Projects will be jointly financed by CEA and IFA for a period of two or three years for research and development activities of CEA and Romanian teams<sup>4</sup>.

## Conditions and requirements

The applications should be presented using the Application Form for Joint Research and Development Projects appended to the Call. The official seal must accompany the signature of the Romanian partner. The deadline for submission is November 16, 2012 (launching date is October 1, 2012).

The Romanian applicants should submit their proposals in Romanian and English language. The proposal should be submitted in both paper and electronic support (CD) version.

The latest date foreseen for the start of the joint R&D projects is March 1, 2013.

The duration of a project can be 24 or 36 months. An accepted project will be financed for the second/third year only on view of yearly reports (including financial sheet) and if the initial plan is respected.

For the Romanian participants the total budget requested for a project cannot exceed 900 000 LEI for a project of 36 months or 600 000 LEI for a project of 24 months (maximum 300 000 LEI per year).

Applications must be submitted in parallel to IFA - Romania and CEA - France, until November 16, 2012. Only jointly submitted proposals will be eligible for evaluation.

An internal evaluation procedure (mark 0 to 5) of the proposals will be performed by each body according to the following criteria:

- 1. Scientific and/or technological relevance and quality of the proposal.
- 2. Qualification and expertise of the teams.
- 3. Compliance with national priorities/strategies in the field.
- 4. The potential impact through the development, dissemination and use of project results.

- 5. Sustainability of the cooperation.
- 6. Quality and efficiency of the work and financial plans.

The participation of at least one young scientist (up to 35 years of age) in each team (Romanian and CEA) is compulsory: only such proposals are eligible for evaluation.

The common selection of the projects will be based on the results of the internal evaluation process in each country and will be done by the Management Committee, which has been settled according to the General Agreement signed by the two bodies and which will meet in the end of January 2013.

Applicants will be notified upon the final decision about their project proposal, after the meeting of the Management Committee, by the beginning of February 2013.

## 2. Joint Support Actions Projects

The projects will be jointly financed by CEA and IFA for a period of up to six months for preparing and submitting joint proposals of CEA and Romanian teams under EU programmes and initiatives (e.g. FP7 and FP7 - EURATOM, etc.) as well as for future IFA-CEA calls concerning Joint Research and Development Projects.

The projects can be in any field specified in the article 3 of the General Cooperation Agreement for Scientific Research between IFA and CEA.

#### Conditions and requirements

The applications should be presented using the Application Form for Joint Support Actions Projects appended to the Call. The official seal must accompany the signature of the Romanian partner.

Applications are accepted and processed continually for the entire period of validity of the General Cooperation Agreement for Scientific Research between IFA and CEA.

The Romanian applicants should submit their proposals in Romanian and English language. The proposal should be submitted in both paper and electronic support (CD) version at least two months before the envisaged start of the project.

The maximum duration of a project is 6 months and it must end before the deadline for submitting the joint proposal under EU programme/initiative or a new IFA-CEA call for Joint Research and Development Projects.

The funding will provide non-refundable grants with the following eligible types of expenditure: (i) travelling expenses incurred by own experts; (ii) cost of visits incurred by foreign experts. As the Romanian side is concerned, funding of the accepted projects will be provided as follows: (a) a maximum number of 6 travelling tickets (international transport) per project for the Romanian experts; (b) costs of accommodation, daily

allowance and internal transportation, according to the legal provisions into force, incurred by the visits of the French experts for a maximum period of 30 days per project.

For the Romanian participants the total budget allocated for a project cannot exceed 30 000 LEI.

Applications must be submitted in parallel to IFA - Romania and CEA - France at any time but not later than three months before the deadline for submitting the joint proposal under the EU programme/initiative or under the new IFA-CEA call for Joint Research and Development Projects. Only jointly submitted proposals will be eligible for evaluation. Evidence of the envisaged calls for proposal targeted by these joint support actions projects will be provided when submitting the applications.

An internal evaluation procedure (mark 0 to 5) of the proposals will be performed by each body according to the following criteria:

- 1. Scientific and/or technological relevance and quality of the proposal.
- 2. Qualification and expertise of the teams.
- 3. Relevance to the objectives of the specific EU programme/initiative.
- 4. Compliance with national priorities/strategies in the field.
- 5. The potential impact through the development, dissemination and use of projects results.

The participation of at least one young scientist (up to 35 years of age) in each team (Romanian and CEA) is compulsory: only such proposals are eligible for evaluation.

The common selection of the projects will be based on the results of the internal evaluation process in each country and will be done by the Management Committee, which has been settled according to the General Cooperation Agreement for Scientific Research between IFA and CEA. An official letter containing the title of the accepted projects, name of the projects leaders, period of funding and costs covered will be exchanged between the two bodies (CEA and IFA), aiming to validate the joint selected projects and synchronize the duration and funding of these projects.

Applicants will be notified upon the final decision about their project proposal within one month from the receiving date of the application.

The application form should indicate if there is already a Specific Agreement between the parties. Successful applications must have a Specific Agreement<sup>5</sup> signed between the parties before starting the project.

Written proposals along with the attached documentation and with the label "Do not open – Application relevant to the General Cooperation Agreement for Scientific Research between IFA - Romania and CEA - France" must be submitted in closed envelopes to the addresses mentioned above.

Incomplete, late and inadequately labelled applications will not be considered.
